Important Instructions to all Room Air Conditioners manufacturers and permittee

This is with reference to the validity of star rating tables 2.2 & 2.3 as mentioned in Schedule 3 for Room Air Conditioners. Subsequently the following tables shall be applicable w.e.f 1st January, 2016.

Note: There is no change in star level, whereas the validity of respective air conditioner table have been revised.

2. The star level chosen for the models will be based on minimum & maximum limits of energy efficiency ratios of each star level band specified in tables above. The permission for display of particulars on the unitary air conditioners for **1 star (EER 2.50 – 2.69) specified in table 2.5 and 1:1 high wall split air conditioners for star 1 (EER 2.70-2.89) specified in Table 2.6 shall not be permitted with effect from 01.01.2016** with a view to upgrading the minimum energy performance level of such air conditioners.

3. For cassette & floor standing type split air conditioners, star 1 (EER 2.70 – 2.89) shall be applicable (which will be mandated from 01/01/2016)

4. Instructions for the manufacturers who wish to continue the existing models:

1. A declaration in **Form IV** on company letter head (with stamp & sign of authorised signatory) shall be submitted to the Bureau
2. All the existing models are valid till 31st December 2015 and will be automatically expired.
3. Once approved, the model with revised star level will directly appear in Search & Compare page of BEE star label website (<http://www.beestarlabel.com/Home/Searchcompare>).

4. How to apply:

All the models will appear in manufacturer's portal and in order to continue, the permittee need to go to 'Continuation' option as mentioned below.

Change Label to New Label (Continuation)

The links (marked in red colour) would directly appear in manufacturer's portal w.e.f 1st November, 2015.

Note:

- a. After applying for continuation of label, the model with modified star level will directly appear in BEE's search & compare page. BEE will not issue separate approval letter in case of 'Continuation'.*
- b. Once models are expired automatically, manufacturer need to apply afresh & the existing procedure shall be applicable for fresh registration.*
