

## Bengal prohibits Togadia from entering state

**KOLKATA:** The West Bengal government on Wednesday announced that it had issued a prohibitory order banning the entry of Vishva Hindu Parishad (VHP)'s international working president, Praveen Togadia, from entering the state.

The order, passed on March 31, 2015, will be effective for the next two months.

According to a state home department official, the order was passed as the state government thought that Togadia's entry or his holding of closed door or public meetings or rallies would lead to communal tension in the state and cause disturbance to public tranquillity.

When contacted, the VHP general secretary in West Bengal, Chinmoy Dutta said that the state government passed this order to unnecessarily heckle Togadia. "He is supposed to come to Kolkata on April 3, following which he will have an internal meeting on April 4. He is also scheduled to hold meeting in north Bengal. The programme schedule will not change," Dutta said.

## CAG slams Guj on state of affairs

**AHMEDABAD:** The Comptroller and Auditor General (CAG), in its report presented in the state assembly on March 31st, slammed the Gujarat government on a wide range of issues including social and education indicators, agricultural growth and industrial sector besides fiscal discipline.

Reports of CAG on state's finances, revenue sector, public undertaking, economic sector and general and social sectors were presented in the House for the year 2013-2014, during which Narendra Modi was the chief minister of the state.

The auditor rapped the state government on continuing decline in the child sex ratio. "As per Census 2011, the trend of overall sex ratio of the state (Gujarat) has declined from 920 girls to 919 girls), though the all-India ratio had improved from 933 girls to 943 girls per 1,000 boys as compared to Census 2001," the CAG social sector performance audit said.

The CAG report expressed dissatisfaction on the steps taken by the Gujarat government to stop

female foeticide and on child marriages for which 659 complaints were received during 2009-14 and only 15 cases were filed.

The state's performance in primary education sector also fared poorly in the auditor's scrutiny. In the CAG's compliance audit of the Sarva Siksha Abhiyan (SSA) scheme in Gujarat, it stated that out of

43,176 government-run schools in the state, 64 schools having 5,698 students ran without any teacher. Further, 874 schools functioned with merely one teacher as on March 2014.

Similarly, the state's much hyped agriculture sector was also exposed by the CAG, which found negative growth rate during the year 2012-13.

As against 21.64% growth in 2010-11 and 5.02% growth in 2011-12, Gujarat registered -6.96% growth in 2012-13, which was the first year of 12th Five Year Plan, stated the CAG report.

Besides social sectors, the CAG also audited state's public sector undertakings (PSUs) noting that 20 PSUs incurred losses of ₹1,111.85 crore.

## GOVT SAYS UGC A STATUTORY BODY, CAN'T BE SCRAPPED

**NEW DELHI:** In the wake of a committee constituted to review working of the University Grants Commission (UGC) reportedly suggesting that the body be scrapped, the government on Wednesday said that the UGC was formed by an Act of Parliament and could not be scrapped unilaterally.

"UGC has been created by an Act of the Parliament and cannot be unilaterally scrapped," the ministry said in a release.

"The report is yet to be examined in the ministry... The mandate given to the committee was to analyse, review and recommend to the ministry, the architecture required, and the ministry will have to take a view after going through it threadbare," the ministry said. "Hence, no such decision has been taken and the recommendations are yet to be understood and analysed before any decision is taken in the matter."

The committee, set up under former UGC chairman Hari Gautam, suggested setting up of a "national higher education authority" to replace the UGC. The new statutory agency should have wide-ranging and quasi-judicial powers on setting standards in higher education, it is believed to have suggested.

In the meantime, the committee recommended improving the organisational structure and functional status of the UGC. It reportedly said that the present body had not only "failed to fulfil its mandate but also had not been able to deal with emerging diverse complexities."

The committee suggested that categorisation of universities should be replaced with an efficient model, a national research aptitude test for admission to PhD and a single tenure of VCs, besides scrapping a criterion that requires 10 years as professor to be eligible for VC.

**CHENNAI:** The politically powerful Maran family leveraged its clout — both at the Centre and Tamil Nadu — to build a profitable business empire that ranged from television stations to airlines.

Kalanidhi Maran, elder brother of former Union minister Dayanidhi Maran, had wanted to own one channel in every language operating across India when he started Sun TV in 1993. However, the pan-India television empire was out of reach. He then concentrated on South India and emerged as the single largest player in television with 32 channels.

The Maran brothers realized the importance of media and along the way, Kalanidhi acquired two Tamil dailies and six magazines to emerge as a powerful media conglomerate

in South India with presence in all four major languages — Tamil, Telugu, Kannada and Malayalam. The group's cable business — Sumangali Cable Vision (SCV) — is with Dayanidhi while Kalanidhi Maran is the managing director of the Sun media empire. In 2012, the media empire that the brothers built in three decades stood at a value of ₹13,500 crore.

Kalanidhi's pan India dreams were realised when he bought 45 FM stations across the country.

And after acquiring a struggling Spicejet in 2010, Kalanidhi had announced proudly "Finally, I connect every part of India." But recently, Maran tried to offload his stake when Spicejet nosedived and had to be put on sale to save it from crashing out of business.

After airlines, the Marans turned their attention to cricket and IPL. In 2012 when Deccan Chargers was up for sale, Maran bought the Hyderabad IPL team with a ₹85.05 crore a year bid for the next five years — a total of ₹425.25 crore.

For the Maran brothers, things took a turn for worse in 2011 when businessman C Sivasankaran complained to the CBI that he was forced to sell his telecom venture, Aircel, to Maxis in 2005 by the Maran brothers. It is in this case that the Enforcement Directorate has ordered attachment of the properties of the brothers valued at ₹724 crore on Wednesday.

## SC seeks CBI reply on Swamy's plea

**NEW DELHI:** The Supreme Court on Wednesday sought response from the CBI on BJP leader Subramanian Swamy's plea alleging that two senior CBI officers — probing the 2G spectrum cases — have been shifted from the case.

A bench of Chief Justice H.L. Dattu and justice Arun Mishra said it would first give a hearing to CBI on the reason behind the transfer and then take a call whether to ask the agency to re-transfer the officer concerned.

"You (CBI) reply to it (Swamy's application), on what reason you have transferred him (joint director Ashok Tewari)," the court said.

The court's direction came on a plea moved by Swamy who alleged that the transfer of

officers involved in the investigation of 2G spectrum scam was against the SC's direction that no officer be disturbed till the probe was complete.

The court asked the agency to file their reply within two weeks and slated the matter for further hearing on April 20.

Swamy said another officer, additional director RK Datta, to whom Tewari has been reporting, has been empanelled as special director in the government and was also likely to be shifted.

"Such transfers while the investigation was still going on, is in direct contradiction of the orders of this court," the plea said.

Swamy said the court must pass an order to bring back Tewari and retain Datta to enable them continue the ongoing probe in the 2G case till the trial was completed.
