### Important Instructions to all Manufacturers & Permittees of Frost Free Refrigerators (FFR) and Direct Cool Refrigerators (DCR)

1. All manufacturers/permittee of Refrigerators under S&L program of BEE are hereby informed that the validity of existing star rating table for Frost Free Refrigerators and Direct Cool Refrigerators under mandatory regime has been extended up to 31<sup>st</sup> December, 2022 vide S.O. 2758 (E) and S.O. 2759 (E) respectively. The copies of said Gazette Notifications are enclosed with this Alert.
2. Please note that the manufacturers/ permittees of FFR and DCR, who wish to continue use of approved BEE star label, shall submit application for continuation and sample label to BEE with revised label validity period as **1<sup>st</sup> January, 2020 to 31<sup>st</sup> December, 2022.**
3. For models already approved by BEE, all the registered manufacturers/ permittees are required to submit the proforma enclosed with this Alert seeking willingness to continue the registered models with BEE. The portal to seek application for continuation of already approved models till 31<sup>st</sup> December, 2022 has been made live and will be open till 20<sup>th</sup> September, 2022.
