**Important Instructions for all manufacturers/permittees registered under S&L program for Tyres**

1. All manufacturers/permittees of Tyres under S&L Program of BEE are hereby informed that the validity of the existing star rating table of Tyres has been extended till **31<sup>st</sup> December, 2024**. Accordingly, the revised sample label validity period is **1<sup>st</sup> January 2022 to 31<sup>st</sup> December, 2024**.
2. The manufacturers willing to continue the registered models approved by BEE beyond 31<sup>st</sup> December, 2023 shall upload the previous approval letter with revised sample label on portal latest by 31<sup>st</sup> December, 2023.
3. For models already approved by BEE, the manufacturers/permittees have to submit the proforma enclosed with this advisory for their willingness to continue the registered models with BEE beyond 31<sup>st</sup> December, 2023.
4. Kindly note, no continuation of application for models would be accepted beyond 31<sup>st</sup> December, 2023 and models for which such requests are not received timely shall get deactivated automatically after 31<sup>st</sup> December, 2023. The portal to seek application for continuation of already approved models till 31<sup>st</sup> December, 2024 has been made live w.e.f 26.10.2023.
