**Important instructions to all Manufactures & Permittees of Washing Machine**

1. This is with reference to the implementation of S&L program for Washing Machine under mandatory regime w.e.f. 1<sup>st</sup> January, 2024. The notifications for Washing Machine have been published in Gazette of India vide S.O. 4674 (E) and S.O. 4675 (E) dated 26<sup>th</sup> October, 2023 and regulations have been published on 31<sup>st</sup> October, 2023.
2. Please note that the existing energy performance standards of Washing Machine under voluntary regime will be valid only till 31<sup>st</sup> December, 2023. The validity period of the revised energy performance standards for washing machine under mandatory regime is from 1<sup>st</sup> January, 2024 to 31<sup>st</sup> December, 2026.
3. Accordingly, it may please be noted that, for application (Fresh/Label change), the revised label validity period will be from 1<sup>st</sup> January, 2024 to 31<sup>st</sup> December, 2026.
4. The Washing Machine with revised label period shall not be delivered at retail outlets prior to 1<sup>st</sup> January, 2024 (i.e. effective date for mandatory changeover).
5. Every manufacturer/permittee willing to continue with the existing model, already awarded Star Label by BEE has to apply for "continuation option" (degradation option, for eg. 3 star to 2 star) and get Star Label for its model as per the revised energy performance standard on or before 31<sup>st</sup> December, 2023. The relevant link will be available on the S&L portal w.e.f **17<sup>th</sup> November, 2023 at 15:00 hrs.**
6. Following steps need to be followed for seeking degradation label:

**Step 1:** Login to [www.beestarlabel.com](http://www.beestarlabel.com) portal to apply for "continuation of model" and click on link available against each model.

**Step 2:** Fill the degradation form for the model that you wish to continue and upload the sample label (as per new energy performance standard and label validity period) and previous approval letter issued by BEE for that specific model.

**Step 3:** Complete the payment process by paying a degradation fee of Rs. 1000/- per model.

Note: The documents should be sealed and signed by the authorized signatory.

7. Manufacturers/Permittees are allowed to register fresh models or renewal of already registered models (as per the new star rating table) any time from **17<sup>th</sup> November, 2023 at 15:00 hrs.**
8. Every manufacturer/permittee, willing to renew their already registered models, have to submit a valid test report with application fee of Rs. 1,000/- per model to BEE. For fresh models, a registration fee of Rs. 2,000/- per model is applicable.
