#### Important Instructions to all manufacturers/ permittees registered under S&L program for Colour Television

1. All manufacturers/ permittees of Colour television under S&L program of BEE are hereby informed that the validity of existing star rating table for Colour television under Mandatory regime has been extended up to **30<sup>th</sup> June, 2022**. The said Gazette Notification is available at news and announcement section of Standards and Labeling portal for reference.
2. Those manufacturers/ permittees of Colour television, who wish to continue use of approved BEE star label, shall submit sample label to BEE with revised validity period as **1<sup>st</sup> January, 2019 to 30<sup>th</sup> June, 2022**.
3. For models already approved by BEE, all the registered manufacturers/ permittees are required to submit the proforma enclosed with this Alert seeking willingness to continue the registered models with BEE beyond 31<sup>st</sup> December, 2021 latest by **24<sup>th</sup> December, 2021**. The portal to seek application for continuation of already approved models till 30<sup>th</sup> June, 2022 has been made live.
