Important Instructions to all Manufacturers & Permittees of Colour Televisions

1. The validity of the existing energy consumption standards of Colour Televisions is valid till 30th June, 2022.

In accordance with provisions of amendment notification of Colour Televisions vide S.O. 2369(E) dated 24th May, 2022, the revised energy consumption standards would be applicable from 1st July, 2022 and would be valid till 31st December, 2024.

Therefore, the revised validity period to be displayed on the new label shall be from **1st July, 2022 to 31st December, 2024.**

2. Please note that all the existing models are valid only till 30th June, 2022 and will be expired automatically after the expiry of the validity period.
3. Under the activity "Change label to New label", once approved, the models with revised label period will directly appear on Search & Compare page of BEE's star label website (<https://www.beestarlabel.com/SearchCompare>).

Key steps to apply for the activity- "Change label to New label"

- (i) Login to your portal.
- (ii) List of active/already approved models of Colour Television will appear.
- (iii) Click the degradation link "Change Label to New Label" visible against each model.
- (iv) Submit the requisite details sought in the form.
- (v) Upload the following documents:
 1. Earlier approval letter for the model issued by BEE.
 2. New sample label for the model as per revised energy consumption standards.
- (vi) Submit the "Change label to New label" application.
- (vii) Proceed to payment gateway to pay a label change fee of Rs. 1000/-.

Note: The link would be active w.e.f. 08th June, 2022 till 08th September, 2022.
