**Important Instructions to all manufacturers/permittee registered under S&L program for Storage Type Electric Water Heater**


1. In terms of the Gazette notification dated 24<sup>th</sup> December, 2018, the existing energy consumption standards for Storage Type Electric Water Heater are valid till 31<sup>st</sup> December, 2020 and the revised energy consumption standards are to be made effective from 1<sup>st</sup> January, 2021.
2. In view of the adverse impact of the COVID -19 pandemic on the business of Indian Storage type Electric Water Heater manufacturing Industry, BEE received a joint representation from committee members and other registered manufacturers of Storage water heater dated 24<sup>th</sup> June, 2020, requesting an extension in adopting the new testing methodology currently under preparation for storage type electric water heater.
3. Accordingly, the existing energy consumption standards for Storage type Electric Water Heater shall be valid for a period of another 6 months starting 1<sup>st</sup> January, 2021 to 30<sup>th</sup> June, 2021.
4. In this regard, it is to mention that amendment notification of Storage type Electric Water Heater has been published in the Gazette of India vide S.O. 4486 (E). A copy of the Gazette Notification is attached with this alert for your ready reference please.
5. It may please be noted that the revised validity period of the sample label will be from 1<sup>st</sup> January, 2019 to 30<sup>th</sup> June, 2021.
6. Accordingly, the portal to seek continuation approval for already approved star labelled models till 30<sup>th</sup> June, 2021 has been made live.
7. Kindly follow the following steps given below to submit the applications for seeking continuation approval:
  1. Login your portal;
  2. Select the option "Change of Label to New Label";
  3. Submit the consolidated self-declaration form (duly sealed & signed) in the format enclosed with this alert;  
(Please note: Uploading the self-declaration form is one-time activity only)
  4. Click on the "Continuation Link" available for list of already approved models;
  5. For each model, submit the mandatory declaration form for seeking permission to affix revised star label.
  6. Upload the Earlier approval letter and new sample label
  7. Click on "Submit".

*Note: No renewal fee of Rs. 1000/- has to be paid while seeking the continuation approvals.*

**S.O. 4486(E).**— In exercise of the powers conferred by clause (a) of section 14 of the Energy Conservation Act, 2001 (52 of 2001), the Central Government, in consultation with the Bureau of Energy Efficiency, hereby makes the following rules further to amend in the notification of the Government of India in the Ministry of Power vide notification number S.O. 6308 (E), dated the 24th December, 2018, namely:-

In the said notification, in paragraph 3, in Table 3.3, in sub-paragraph (1), for the figures and words “1st January, 2019 to 31st December, 2020”, the figures and words “1st January, 2019 to 30th June, 2021” shall be substituted.
