

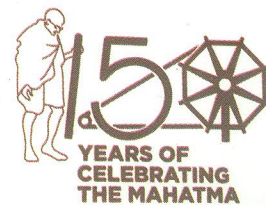

Important Instruction for all LED lamp manufacturer and Permittee

1. Amendment Notification under clause (a) of Section 14 of the EC Act for Self-ballasted LED lamp has been notified vide S.O. 3631 (E) on 9th October, 2019. A copy of the Amendment Gazette Notification is available on BEE's website www.beestarlabel.com
2. The validity of existing energy consumption standards for LED lamp (that were valid from 1st January, 2018 to 31st December, 2019) has been extended for a period of 6 months i.e. from 1st January, 2020 to 30th June, 2020, followed by ratcheting up of energy consumption standards w.e.f. 1st July, 2020. Accordingly, the revised validity period to be displayed on the new label shall be from 1st January, 2018 to 30th June, 2020.

Note: There is no change in the existing star rating levels however only the validity has been revised for a period of six months.

3. Accordingly, all the approved models of LED lamps would expire automatically on 31st December, 2019. Therefore the manufacturers who wish to continue the approval of LED lamps have to follow the procedure mentioned below.
4. **Instructions for the permittee who wish to continue the existing models:**
 - (i) If the permittee is willing to continue with the existing models, they have to select "Continuation option" (Degradation option) being displayed on manufacturer's portal, fill relevant details and send back the required documents to BEE with stamp and sign of the authorized signatory.
 - (ii) The permittee shall submit the renewal fee of Rupees One thousand per model only through an acceptable online mode of payment.
 - (iii) The permittee shall submit the following documents to BEE on or before 31st December, 2019:
 - (a) Hard copy of degradation form.
 - (b) Previous approval letter issued by BEE.
 - (c) New label with revised label period.
 - (iv) All the existing models are valid only till 31st December, 2019, and would expire automatically after the expiry of validity period.
 - (v) Once approved, the model with revised label period will directly appear on Search and Compare page of BEE star label website (<http://www.beestarlabel.com/Home/Search&compare>)

5. **Steps to apply for Continuation (Degradation):**

- (i) Login the manufacturer's portal.
- (ii) Select the continuation link i.e. "Change Label to New label".
- (iii) List of previously approved models will be displayed.
- (iv) Select "Proceed for Continuation" and fill relevant details.
